PROCEEDINGS OF THE FRANKLIN COUNTY BOARD OF SUPERVISORS

AUGUST 23RD, 2021

The Board of Supervisors met at 8:30AM on Monday, August 23rd, 2021, at the Franklin County Courthouse with Board members Mike Nolte, Gary McVicker, & Chris Vanness in attendance.

Chairman Nolte led the Pledge of Allegiance.

Motion by McVicker, Seconded by Vanness to approve the Agenda as presented. All ayes. Motion carried.

Motion by Vanness, Seconded by McVicker to approve the Board Minutes dated 8/16/21 & 8/19/21 and Drainage Minutes dated 8/19/21 with a few corrections. All ayes. Motion Carried.

Public Comment & Board Committee Reports: Ryan Peterson, Maintenance Director, gave the board an update on replacing some glass partitions at the courthouse. McVicker attended a regional mental health meeting where they voted to move forward with conversations with Franklin Co regarding being the employer of record. Nolte attended Conservation and ARPA Task Force.

Jay Waddingham, County Engineer met with the Board and gave an update on his department.

Motion by Vanness, Seconded by McVicker to approve a Franklin Co Utility Permit App for MidAmerican Energy to replace single phase with three phase line along 105th St. from S56 to 2010 105th St. All ayes. Motion carried.

Aaron Dodd, Sheriff, met with the board to provide an update on his department.

Katy Flint, Auditor, gave the board an update on her department.

A drainage meeting was held at 10:00AM regarding JDD4-118 and DD48 to accept the Appraisers Reports on Damage Claims. Full details may be obtained from the drainage clerk or on the county website.

Lisa Hill, CICS Building Manager, met with the board to discuss the parking situation at their building. They have an average of 10-12 people parking in the lot that are not clients or employees and it is becoming a problem. Motion by McVicker, Seconded by Vanness to approve a letter being sent to neighboring property owners letting them know they will no longer be allowed to utilize the lot. All ayes. Motion carried.

There was discussion regarding the proposed bidding requirements & procedures policy. The Auditor will finalize the Boards recommendations and bring the policy back for approval at the next meeting.
