Watts moved with Latham seconding, to approve Resolution 2021-24, WHEREAS, it is deemed necessary and advisable that Cerro Gordo County, State of Iowa, should provide for the authorization of a Loan Agreement and issuance of General Obligation Refunding Capital Loan Notes, to the amount of not to exceed \$4,600,000, as authorized by Sections 331.402, 331.441 and 331.443, of the Code of Iowa, for the purpose of providing funds to pay costs of carrying out essential county purpose project(s) as here-inafter described; and WHEREAS, the Loan Agreement and Notes shall be payable from the Debt Service Fund; and WHEREAS, before a Loan Agreement may be authorized and General Obligation Refunding Capital Loan Notes, issued to evidence the obligation of the County thereunder, it is necessary to comply with the provisions of the Code of lowa, as amended, and to publish a notice of the proposal and of the time and place of the meeting at which the Board proposes to take

action for the authorization of the Loan Agreement and Notes and to receive oral and/or written objections from any resident or property owner of the County to such action. NOW. THEREFORE, BE IT RE-SOLVED BY THE BOARD OF SU-PERVISORS OF CERRO GORDO COUNTY, STATE OF IOWA: Section 1. That this Board meet in the Board Room, County Courthouse, 220 North Washington, Mason City, Iowa 50401, at 10:15 a.m., on the 16th day of February, 2021, for the purpose of taking action on the matter of the authorization of a Loan Agreement and issuance of not to exceed \$4,600,000 General Obligation Refunding Capital Loan Notes, for essential county purposes, the proceeds of which notes will be used to provide funds to pay the costs of refunding outstanding indebtedness of the County, including

the County's General Obligation Refunding Capital Loan Notes, Series 2012A, dated January 26, 2012. Section 2. The Auditor is authorized and directed to proceed on behalf of the County with the negotiation of terms of a Loan Agreement and the issuance of General Obligation Refunding Capital Loan Notes, evidencing the County's obligations to a principal amount of not to exceed \$4,600,000, to select a date for the final approval thereof, to cause to be prepared such notice and sale

information as may appear appropriate, to publish and distribute the same on behalf of the County and this Board and otherwise to take all action necessary to permit the completion of a loan on a basis favorable to the County and acceptable to the Board.

That the Auditor is hereby directed to cause at least one publication to be made of a notice of the meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circula-tion in the County. The publication to be not less than four clear days nor more than twenty days before the date of the public meeting on the issuance of the Notes.
