YOU AND EACH OF YOU ARE HEREBY NOTIFIED that the Board of Supervisors of Cerro Gordo County, Iowa, acting as trustees on behalf of Drainage District No. 120 in said county has employed Kent L. Rode, P.E., Bolton & Menk as an engineer to determine the feasibility or the necessity of having repairs, and/or improvements, all concerning the drainage facilities of Drainage District No. 120 in order to provide adequate drainage and relief for the lands included in said Drainage District No. 120.

YOU ARE FURTHER NOTIFIED that the Board of Supervisors of Cerro Gordo County requested that said engineer make a preliminary survey and investigation of the possible repairs or improvements of Drainage District No. 120.

YOU ARE FURTHER NOTIFIED that drainage engineer, Kent L. Rode, P.E. has filed his report with the Auditor of Cerro Gordo County in which he recommends certain repairs and improvements. That the engineer's estimate for the costs of the proposed repairs and improvements are as follows:

YOU ARE FURTHER NOTIFIED that this report and recommendations in full are on file in the office of the Cerro Gordo County Auditor at the Courthouse in Mason City, Iowa, for your information. Electronic copies of the report may be obtained via email by contacting the auditor's office at sshonka@cgcounty.org. You are encouraged to review the report

prior to the date set for hearing in this notice. Said report has been reviewed and considered by the Board of Supervisors and they have been tentatively approved as the board has determined that the repairs and/or improvements are necessary and feasible. The engineers' report also contains the following recommendations and proposals:

1. Annexation & District Right-Of-Way. That at a later date, an annexation of additional lands and the establishment of district right-of-way may be considered by the board, if needed.

2. **Reclassification.** That at a later date, the board may consider reclassification with appropriate adjustment of assessments, if needed.

3. **Interest Rate and Waivers.** The board will consider the appropriate interest to charge and determine the length of time that assessments may be paid of not less than ten (10) nor more than twenty (20) years and the interest rate for this project.

For further particulars, you are referred to the engineer's report for Drainage District No. 120 now on file in the office of the Cerro Gordo County Auditor.

YOU ARE FURTHER NOTIFIED that the Board of Supervisors of Cerro Gordo County, acting on behalf of Drainage District No. 120 has fixed a time and place of hearing on said report and proposed repairs or improvements for July 20, 2021 at 10:15 a.m., at the Cerro Gordo County Supervisors Board Room, Cerro Gordo County Courthouse, 220 N. Washington Avenue, Mason City, Iowa. At said hearing, the Board of Supervisors shall hear objections to the feasibility of such repairs or improvements and of the drainage district as may be presented by and for any landowner in the district. The report of the engineer as filed herein may be amended before final action is taken thereon by this Board of Supervisors. This

hearing may be continued from time to time without further notice as determined by this Board of Supervisors.

YOU ARE FURTHER NOTIFIED THAT ALL OBJECTIONS TO THE ENGINEER'S REPORT OR TO ANY MATTER CONNECTED WITH THIS HEARING MUST BE IN WRITING AND FILED WITH THE CERRO GORDO COUNTY AUDITOR BEFORE THE TIME FIXED FOR HEARING OR DURING THE HEARING ITSELF. THIS INCLUDES THE RIGHT TO FILE A WRITTEN REMONSTRANCE TO THE PROJECT. Further, at the hearing, any interested party may be heard in an argument by himself or by counsel. Anyone who fails to object or remonstrate in writing shall be held to have waived all objections and claims for damages. Finally, any interested party may file a written supporting statement with the Auditor before the time fixed for hearing or during the hearing itself.

YOU ARE FURTHER NOTIFIED that if you fail to object, the Board of Supervisors can make a final decision to make repairs, improvements, and acquire additional right of way. As a consequence of your failure to object you lose your right to appeal the final decision within twenty (20) days to the Iowa District Court.

PROCEEDINGS OF THE BOARD
OF SUPERVISORS

JUNE 22, 2021

The Board of Supervisors of Cerro Gordo County, Iowa, met in regular session pursuant to adjournment. Present: Chairman Casey Callanan, Vice Chairman Chris Watts, Supervisor Tim Latham and various members of the public.

Chairman Callanan convened the meeting at 10:00 a.m.

Latham moved with Watts seconding, to approve today's agenda and the meeting minutes for the June 15, 2021 regular session. Motion passed unanimously.

Public comment session was held. Watts moved with Latham seconding, to approve claims. Motion passed unanimously.

Latham moved with Watts seconding, to appoint Michael Gabor to serve as Drainage Attorney for Drainage District 120 project. Motion passed unanimously.

Watts moved with Latham seconding, to authorize the Chair to sign the GIS Mapping Services Contract with Sidwell. Motion passed unanimously.

Watts moved with Latham seconding, to approve Resolution 2021-70, Whereas, the State of Iowa has appropriated funds for fiscal year July 1, 2021 through June 30, 2022, which moneys are sufficient to fund fully the various local property tax credits/exemptions. And, whereas, Iowa Code Section 25B.7 requires local governments to extend to the taxpayers only those portions of the property tax credits/exemptions that are estimated by the Iowa Department of Revenue and Finance to be funded by the state appropriation. And, whereas the Iowa Department of Revenue and Finance has estimated the percentages of funding for the affected property tax credits/exemptions as follows: Homestead Credit (including Disabled Veteran's Homestead Credit) 100%, Low-income, Elderly, Disabled Credit 100%, Military Exemption 100%, And, whereas the Iowa Department of Revenue and Finance has estimated the prorated percentages of funding for the affected property tax credits as follows: Agland Credit 20.48743124% and Family Farm Credit 14.48028888%. Now, therefore, be it resolved pursuant to Iowa Code Section 25B.7 that the property tax credits/exemptions in Cerro Gordo County for fiscal year July 1, 2021 through June 30, 2022 shall be funded as follows:

Motion passed unanimously. Latham moved with Watts seconding, to approve Resolution 2021-71, WHEREAS, it is desired to transfer monies from the Meservey Depreciation Fund to the Meservey Operations & Maintenance Fund; and, WHEREAS, said operating transfers are in accordance with Section 331.432, Code of Iowa; and, NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Cerro Gordo County, Iowa, as follows:

The sum of Four thousand and 00/100 (4,000.00) dollars is ordered to be transferred from the Meservey Depreciation Fund to the Meservey Operations & Maintenance Fund, effective June 22, 2021. (Transfer #1409) The Auditor is directed to correct his books accordingly and to notify the Treasurer of this operating transfer. Motion passed unanimously.

Watts moved with Latham seconding, to approve Resolution 2021-72, WHEREAS, it is desired to make appropriations, in accordance with Section 331.434(6) of the Code of Iowa; and, NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Cerro Gordo County, as follows:

Section 1. The amounts itemized by account number on the attached schedule are hereby appropriated from the resources of each fund so itemized (The following amounts are for FY 2022).

Section 2. Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2021.

Section 3. In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amounts appropriated pursuant to this resolution. For purposes of this section, the use of holding accounts shall be deemed an appropriate mechanism for the allocation of expenses. Ap-

propriations made to such accounts shall be deemed as sufficient authority for department heads to expend such resources, and will be allocated to expenditure accounts in the same manner as the related expenditures are allocated.

Section 4. If at any time during the 2021-2022 budget year the auditor shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriations, the Auditor shall immediately so inform the board and recommend appropriate corrective action.

Section 5. The auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The auditor shall report the status of such accounts to the applicable departments and officers monthly during the 2021-2022 budget year.
