Mayor Wentz called to order the regular meeting of the Rockwell City Council at 7:00 p.m. All Council members were present. Also present were Star Pralle, Tim Nuehring and Zach Laudner.

Meyer moved to approve the minutes of the previous meeting. Motion seconded by Morrison, carried unanimously.

Worley moved to approve the Library report. Motion seconded by Emhoff, carried unanimously.

Tim Nuehring was present on behalf of the Rockwell Lions Club. Nuehring thanked the Council for their support for the last thirteen years. Nuehring stated that the volunteers and community should also be proud as the event here won the Grand National pull of the year! Nuehring noted they have moved the event to August 4th, 5th and 6th with five sessions during those days. Nuehring asked to have the noise ordinance waived and allow for the pullers to use their ATV-UTV's. Koob moved to waive the noise ordinance until 1:00 a.m. from Thursday August 4th to Sunday August 7th. Motion seconded by Emhoff, carried unanimously Koob moved to waive the ordinance for the ATV-UTV use by the pullers from Thursday to Sunday. Motion seconded by Worley, carried unanimously. Nuehring thanked the

Council as he left the meeting.

At 7:05 p.m. Koob opened the public hearing for the amendment of the 2021-2022 budget amendment. Motion seconded by Worley, carried unanimously. Following discussion. Koob moved to close the public hearing at 7:07 p.m. Motion seconded by Emhoff, carried unanimously.

Worley moved by Resolution 2022-5 to approve the 2021-2022 onded by Meyer. Roll call vote: Ayes: Koob, Worley, Meyer, Morrison and Emhoff. Motion carried unanimously.

Waste Removal. With discussion, Koob moved to approve the rates with Absolute Waste Removal with a full contract for the next meeting clarifying the fuel surcharge. Motion seconded by Morrison, carried unanimously. Weier noted that Absolute Waste

Removal had given information on yard waste removal, allowing a dumpster here and the rates for dumping and landfill charges. Council did not feel this was a viable option for yard waste.

Mayor Wentz stated that we have

by code a utility rate increase of two percent annually. Koob asked about this not covering the rate increase from Absolute Waste Removal for garbage service. Following discussion, Meyer moved to raise the garbage rates \$3.00 per container starting July 1, 2022. Motion sec-onded by Worley, carried unanimously. Koob moved to raise all utility rates by two percent starting July 1, 2022. Motion seconded by Emhoff, carried unanimously.

Wentz stated he has the prelimi-

nary employee evaluations done but with scheduling has not finished, but will prior to the month ending, but would recommend a three percent raise for all employees. Council reviewed and discussed the employee salaries and increases. Meyer moved to give all employees a four percent increase for the 2022-2023 fiscal year, making the following rate increases: Brunstein \$1.22, Laudner .72, Siefken \$1.05 and Weier .90. Motion seconded by Worley, carried unanimously.

Mayor Wentz stated he had a message from the dog owner, which was banned, that they needed to stay in their home with the high heat. Koob asked that we contact the City Attorney about the ramnot fol
